Invitation for Bids for the Asphalt Concreting Work

- The Kerabari Rural Municipality **has allocated funds** from Government towards the cost of Construction of Road and intends to apply part of the funds to cover eligible payments under the Contract **for Asphalt Concreting Work**. Bidding is open to all eligible as per Section V of bidding document..
- Kerabari Rural Municipality, Office of the Rural Municipal Executive** invites electronic bids only from eligible bidders for the construction of **Asphalt Concreting Work** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.
Only eligible bidders with the following key qualifications should participate in this bidding:
 - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **Mention Below.**
 - Minimum Work experience of similar size and nature: **2 Contract of Asphalt Concreting within last 10 year with contract value not less than mention below or equivalent.**
- Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

(19th Apr 2021 A.D.) during office hours** through PPMO's e-GP system . Bidder have to submit their bid electronically and purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the account as specified below .

- Electronic bids must be submitted to the office **Kerabari Rural Municipality, Office of the Rural Municipal Executive, Kerabari Morang** through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 PM on 2078/01/06 B.S. (19th Apr 2021 A.D.)** Bids received after this deadline will be rejected.
- The bid will be opened in the presence of Bidders' representatives who choose to attend at **1:00 PM on 2078/01/19 B.S. (19th Apr 2021 A.D.)** at the office of **Kerabari Rural Municipality, Office of the Rural Municipal Executive, Kerabari Morang**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting mention Below which shall be valid for 30 days beyond the validity period of the bid.
- If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
