5. Electronic bids must be submitted to the office of Kerabari Rural Municipality through PPMO website [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or **before 12:00PM on 1st Asoj 2078 BS**. Bids received after this deadline will be rejected.
6. The bidswill be opened in the presence of Bidders' representatives who choose to attend at **1:00 PM 1<sup>st</sup> Asoj 2078 BS** at the office of Kerabari Rural Municipality. Bids must be valid for a period of [90 days] after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum mention below which shall be valid for 30 days beyond the validity period of the bid.
