5. The bids will be opened in the presence of Bidders' representatives who choose to attend at **1:00 PM** on **17<sup>th</sup> Magh 2078 BS** at the office of Kerabari Rural Municipality. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of **amount mention below** which shall be valid for 30 days beyond the validity period of the bid.
