Invitation for Bids for the Premix Carpeting Road

The Kerabari Rural Municipality, Kerabari, Morang *has allocated funds or received a grant* from *Government of Nepal (GoN)* towards the cost of Premix Road Carpeting and intends to apply part of the funds to cover eligible payments under the Contract *for Premix Road Carpeting* KRMC/MOR/FE./NCB-06(074/75) & KRMC/MOR/FE./NCB-07(074/75)

- 1. Bidding is open to all eligible as per Section V of bidding document.
- 2. The Kerabari Rural Municipality, Kerabari, Morang invites sealed bids or electronic bids from eligible bidders for the construction of *Premix Road Carpeting* under National Competitive Bidding.
- 3. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of *Kerabari Rural Municipality*, *Kerabari, Morang, mailing address, telephone and facsimile numbers and kerabariruralmun@gmail.com]*or may visit PPMO e-GP system www.bolpatra.gov.np/egp.

A complete set of Bidding Documents may be purchased from office of the Kerabari Rural Municipality, Kerabari, Morang and the office of Kerabari Rural Municipality, Kerabari, Morang by eligible Bidders on the submission of a written application, Tax Clearance Certificate 2073/074, VAT registration certificate, along with renewed copy of company/firm registration certificate for 2074/075 and upon payment of a non-refundable fee of NRs.3,000.00 (Three Thousand rupees) on 2075.02.14 (28 May 2018) during office hours. Or Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for esubmission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below.

- 5. Pre-bid meeting shall be held at *Kerabari Rural Municipality Office* at 13:00 hrs on 2075.02.06(20 May 2018)
- 6. Sealed or electronic bids must be submitted to the office of the *Kerabari Rural Municipality, Kerabari, Morang* by hand/courier or through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12.00 PM on 2075/02/15 (29 May 2018). Bids received after this deadline will be rejected. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14.00 PM on 2075/02/15 (29 May 2018) at the office of *Kerabari Rural Municipality, Kerabari, Morang*.
- 7. All bids shall be accompanied by a valid bid security of an amount as shown in the table below. The bid security shall confirm to the standard format as specified in the bid document. Bids shall remain valid for a period of 90 days after the deadline for bid submission and bid security shall remain valid upto 120 days from the deadline of submission of bids.
- 8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid

- security shall remain the same as specified for the original last date of bid submission.
- 9. The Kerabari Rural Municipality reserves right to accept or reject any or all bids for the bidding process without assigning any reason, whatsoever. Other terms and conditions not covered here will be treated in accordance to PPA-2063 and PPR-2064
